

**Declaration regarding conduct of short-term skill development trainings under Utkarsh Bangla Project Mode**

We, <Name of the Training Partner>, an empaneled training partner under PBSSD, hereby, declare that we will conduct the training interventions under Utkarsh Bangla Project Mode while completely adhering to the general terms and conditions as released by PBSSD from time to time as given in <https://www.pbssd.gov.in/publication/index/1/0>.

We, hereby, also declare the below mentioned and any other specific order as released by PBSSD from time to time regarding implementation of Utkarsh Bangla Project Mode.

1. I/ we shall capture the biometric attendance of both trainees and trainers in the centre both at the time of entry as well as departure from the training centre
2. I/ we shall ensure that all biometric attendances are captured adequately and properly using the authorized biometric software as mandated by PBSSD
3. I/ we shall not conduct the training in any of our empaneled training centres in franchise mode
4. I/ we shall conduct trainings by qualified trainers who are mandatorily ToT certified or have applied for ToT certification
5. I/ we shall commence and complete all trainings under Utkarsh Bangla as per the scheduled training commencement and completion dates as given in the Work Order issued
6. I/ we shall maintain complete set of infrastructure in usable and sound condition as mandated by the concerned SSC guidelines
7. I/ we shall not shift the registered training center to any other location without prior approval by PBSSD
8. I/ we shall not conduct any other training programs under any other Government Schemes, Government Departments or paid courses within the same premise as that of the Utkarsh Bangla center
9. All infrastructure used for the purpose of trainings in the center shall be owned/ rented in the name of the training provider and/ or its authorized representatives and shall be dedicatedly used for the concerned training center alone
10. I/ we shall conform to all mandatory branding guidelines under Utkarsh Bangla as mandated by PBSSD
11. I/ we shall raise the request for assessment within fifteen days from the scheduled completion date of the concerned batch
12. I/ we shall not suspend trainings at our empaneled training centers for one or more number of days without prior intimation to PBSSD
13. I/ we shall conduct all trainings in good faith and in the best interest of all the trainees and the State Government conforming to all guidelines as issued by PBSSD from time to time
14. I/ we shall not conduct the trainings in franchise mode with respect to premise, infrastructure, resources, and any other itinerary related to conduct of training
15. I/ we shall follow guidelines of enlisting ITI/ Polytechnic students under Utkarsh Bangla Project Mode interventions
16. I/ we shall also be punishable under any other offences/ anomalies as observed/ reported and deemed fit by the competent authority and shall be punishable under any other Law of the Land for the time being in force.
