SOP: Self Employment Linked to Govt. Scheme / Projects

The Utkarsh Bangla scheme, launched in Feb, 2016, is a flagship scheme of the State Government for skilling related intervention implemented through PBSSD. The scheme has been recently reoriented to make it employment aligned to the emerging needs of the Society, Industry and the Service Sector.

The guidelines has a provision that Self Employment Schemes under various Departments will be linked with Utkarsh Bangla. Beneficiaries of all such schemes would be mandatorily trained under Utkarsh Bangla for skill and entrepreneurship. Accordingly, the demand for training for self-employment is arising from various districts.

Now a Standard Operating Procedure for implementing training for Self Employment related to Govt. Schemes/Projects is being prescribed as follows:

SOP

- a. The self-employment skilling (To be approved / forwarded by concerned Line department) is applicable for :
 - i. Applicants of any Govt. loan as an Individual or as a Group.
 - ii. Members of credit linked SHGs.
 - iii. Members of FPO/ Cooperative Societies with credit linkage.
 - iv. Any other beneficiaries of government projects/schemes.
- b. The training to be organised by any Department / Govt. funded Organisation / Parastatal Bodies / Co-operative Societies / Municipalities / Zilla Parishad / Gram Panchayat or Panchayat Samity, as the case may be.
- c. These organisations would be onboarded in the portal as TP/TC.
- d. The minimum duration of training will be 35 Hours or 5 days.
- e. Course curriculum will consists 'Domain Skill' & 'Entrepreneurship Skill' (if required), as may be suggested /decided in consultation with concerned Line Dept. / Govt. body.
- f. Certification of such training will be done through one of the Councils with the empanelled assessors or assessors from various Line Depts.
- g. Confirmation of Self Employment / linkage with Govt. projects of the Trainee/s need to be done by concerned Line Dept. / Parastatals under those departments.
- h. Payment will be disbursed as per PBSSD Norms for which concerned Dept. / Organisation has to identify a Bank A/C.
